WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of French Creek Equestrian Association (FCEA) allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, lessee, owner, agent, coach, official, trainer, auditor, or volunteer) in an FCEA sponsored event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities; I, for myself, and on behalf of my spouse, children, heirs, next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

- **ACKNOWLEDGEMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any FCEA Event involves risks and danger including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers, or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measure; participants of varying skill levels; situations beyond the immediate control of FCEA event organizers; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK.

Under the laws of most States, an equine activity sponsor or equine professional is not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

- **ASSUMPTION OF RISK:** I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the FCEA sponsored event, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any FCEA sponsored event. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any FCEA event.
- **WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY:** in conjunction with my participation in any FECA event, I hereby release, waive, and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: FCEA, Event Organizers, Event Participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel, any competition managers, the promoters, sponsors, or advertisers of any FCEA event; any charity or other beneficiary which may benefit from the FCEA event; the owners, managers, or lessors of any facilities or premises where a FCEA Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties **(Individually and Collectively, the "Released Parties" or "Event Organizers")**, with respect to any liability, claim(s), demand(s), cause(s) of action, damages(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the FCEA Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.
- **COMPLETE AGREEMENT AND SEVERABILITY CLAUSE:** This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity or enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.

OTHER INFO:

- Members of FCEA that ride both days receive priority when applying to the clinic. Membership policy: must be a recorded member at time of application. Membership may be completed on the web site or mailed in.
- Clinic Info: Snacks & Drinks provided for participants during the day. Please bring a chair. Appropriate schooling show attire is requested, braiding is optional. Horses may wear boots or wraps. Video taping is allowed. Rider is permitted to have a groom in attendance at the clinic.
- Cancellation Policy: In case of rider cancellations, lessons will be filled from the waiting list. Waiting list will be established based on postmark date. If a replacement rider can not be found, the lesson fee is forfeited.
- Rider Schedules will be emailed from Fay at nhf2054@gmail.com or Michelle at kmk0906@aol.com about 5 days before clinic. You will be notified when your entry is received. The clinic this year allows for 10 rides per day.
